POSTPONEMENT OF MAY 2, 2020 SCHOOL BOARD ELECTION TO NOVEMBER 3, 2020

The Board acknowledges that pursuant to his powers as Governor of the State of Texas, Greg Abbott has issued a proclamation suspending Section 41.0052 (a) and (b) of the Texas Election Code to the extent necessary to allow political subdivisions that would otherwise hold elections on May 2, 2020 to move their general and special elections for 2020 only to the next uniform election date, occurring on November 3, 2020, without otherwise adjusting the term of office.


The Board confirms that the candidate filings for the election will remain valid for the election held on November 3, 2020 and that the filing period will not be re-opened for the November election date.


The Board confirms that all applications for a ballot by mail (ABBMs) for voters that are voting by mail due to being over the age of 65 or due to disability will still be valid for the postponed election, and that the ABBMs for voters who submitted ABBMs based on expected absence from the county would not be valid for the postponed election.

The Board acknowledges the major relevant dates for the November election, including voter registration deadline (October 5, 2020), the deadline to submit and ABBM (October 23, 2020), and the dates for early voting (October 19, 2020 – October 30, 2020)

Motion made by Kim Pettiet and seconded by Bill Hont to postpone the May 2, 2020 school board election to November 3, 2020. Motioned carried failed by a majority vote.
