

**REGULAR SESSION OF THE
COMMISSIONERS COURT OF VAN ZANDT COUNTY
9:00 A.M., WEDNESDAY DECEMBER 31, 2025**

The Commissioners' Court of Van Zandt County met at the above-named date and time in the County Courtroom in the Van Zandt County Courthouse in Canton, Texas. Members present were County Judge Andy Reese, Commissioner Pct. 1 Mitch Curtis, Commissioner Pct. 2 Cliff Williams, Commissioner Pct. 3 Bobby Phillips and Commissioner Pct. 4 Brandon Barton. Notice was given by posting in compliance with Section 551.041 of the Government Code on all the following before the Court for consideration:

CALL TO ORDER AND ANNOUNCE QUORUM. 9:01 A.M. All present.

GENERAL ANNOUNCEMENTS. Commissioner Brandon Barton recognized Jimmie Shepard with a 10 year pin.

PUBLIC COMMENTS (ON AGENDA ITEMS ONLY) Steve Horwitz spoke on item #11. Ann Nelson spoke on item # 11.

DISCUSS AND CONSIDER BOARD APPOINTMENTS FOR ESD #1. Ross Hamilton, Tom Troll, William Scott Adams (reappointments) Motion to approve by Commissioner Phillips. (Motion is withdrawn). Judge Andy Reese suggested an evening meeting. Motion to table item by Commissioner Brandon Barton and second by Commissioner Mitch Curtis. All voted in favor.

DISCUSS AND CONSIDER BOARD APPOINTMENTS FOR ESD #2. John David Savage, Kelly Walker. Motion to table item by Commissioner Mitch Curtis and second by Commissioner Bobby Phillips. All voted in favor.

DISCUSS AND CONSIDER THE CHANGE ORDER REQUEST IN ROAD & BRIDGE MATERIALS FROM 4M TRUCK TRAILER AND EQUIPMENT, FOR CRUSHED ROCK 1 ¾" FLEX BASE DELIVERED FOR PCT. 2 AND PCT. 3 ONLY, AND TO CONFIRM PRICE FROM NEXT LOWEST BIDDER, WOODRUM CONSTRUCTION. Representative from 4 M Steve McLaughlin stated price increase of at least 10% \$32.00/ton. Representative from Woodrum Brian Woodrum pricing for Pct. 2 is \$32.00/ton and for Pct. 3 \$30.00/ton. Commissioner Cliff Williams. All voted in favor.

DISCUSS AND CONSIDER AUTHORIZING THE COUNTY JUDGE TO SIGN REVISED INTERLOCAL AGREEMENT NORTH TEXAS REGIONAL MOBILITY AUTHORITY (NET RMA) TO PROVIDE ADVISORY SERVICES REGARDING ROADWAY MAINTENANCE METHODOLOGIES AND PLANS RELATED TO ROAD PROJECTS WITHIN THE COUNTY. Motion to approve by Commissioner Cliff Williams and second by Commissioner Mitch Curtis. All voted in favor.

DISCUSS AND CONSIDER AUTHORIZING THE COUNTY JUDGE TO SIGN AGREEMENT WITH SMARSH FOR THE ARCHIVING OF TEXT MESSAGES ON COUNTY PROVIDED MOBILE DEVICES. Scott Slaton spoke cost is \$14,774.00 one time cost first net and (8x8) Judge Andy Reese recommended a workshop to establish retention policy. Motion to table by Commissioner Cliff Williams and second by Commissioner Brandon Barton. All voted in favor.


