

WHERAS, default has occurred in the payment of said indebtedness, and the same is now wholly due and the owner and holder has requested to sell said property to satisfy indebtedness.



All that Certain lot, tract or parcel of land situated within the John Welch Survey, Abstract No. 894, Van Zandt County, Texas, same being a part of that tract of land to the Van Zandt County Land Trust in Document No. 2022-067250, Real Records of Van Zandt County, Texas, and being more particularly described as follows:

BEGINNING at a point for corner, in the north line of said Van Zandt County Land Trust tract and within County Road No. 2023, from which a rail road spike found for the northwest corner of said Van Zandt County Land Trust tract bears South 80 degrees 26 minutes 20 seconds West, 4492.39 feet for witness;

THENCE North 80 degrees 35 minutes 20 seconds East, with said north line and within County Road No. 2023, 80.00 feet to a point for corner;

THENCE South 00 degrees 20 minutes 48 seconds East, passing a 1/2 inch steel rod set and capped "Vogt 5240" at 32.78 feet, in all 2094.82 feet to a 1/2 inch steel rod set and capped "Vogt 5240" for corner;

THENCE South 80 degrees 35 minutes 14 seconds West, 250.00 feet to a 1/2 inch steel rod set and capped "Vogt 5240" for corner;

THENCE North 00 degrees 20 minutes 48 seconds West, 899.00 feet to a 1/2 inch steel rod set and capped "Vogt 5240" for corner;

THENCE North 80 degrees 35 minutes 12 seconds East, 250.00 feet to a 1/2 inch steel rod set and capped "Vogt 5240" for corner;
