

 When Deputies are required to remain on scene or travel out of County on  
 attachment of person for more than Two (2) Hours, plus any damages incurred.  
 MILEAGE FEE FOR TRANSPORTING PERSON/PERSONS OUT OF  
 COUNTY ON ATTACHMENT OF PERSON (witness attachment) ..... .58 cents per mile  
 PRINTING OF E-FILED DOCUMENTS FOR SERVICE ..... \$ 8.00  
 EXECUTING A BILL OF SALE TO EACH PURCHASER  
 OF PERSONAL PROPERTY UNDER AN EXECUTION  
 OR ORDER OF SALE ..... \$ 50.00  
 COLLECTING MONEY ON AN EXECUTION OR ORDER OF SALE ..... 10% of  
 the amount collected. Total Commission per sale limited to \$2500.00 plus costs.  
 COLLECTING ON AN EXECUTION OR ORDER- BUT WITHOUT SALE ..... 5% of  
 the amount collected. Total Commission per sale limited to \$2500.00 plus costs.




